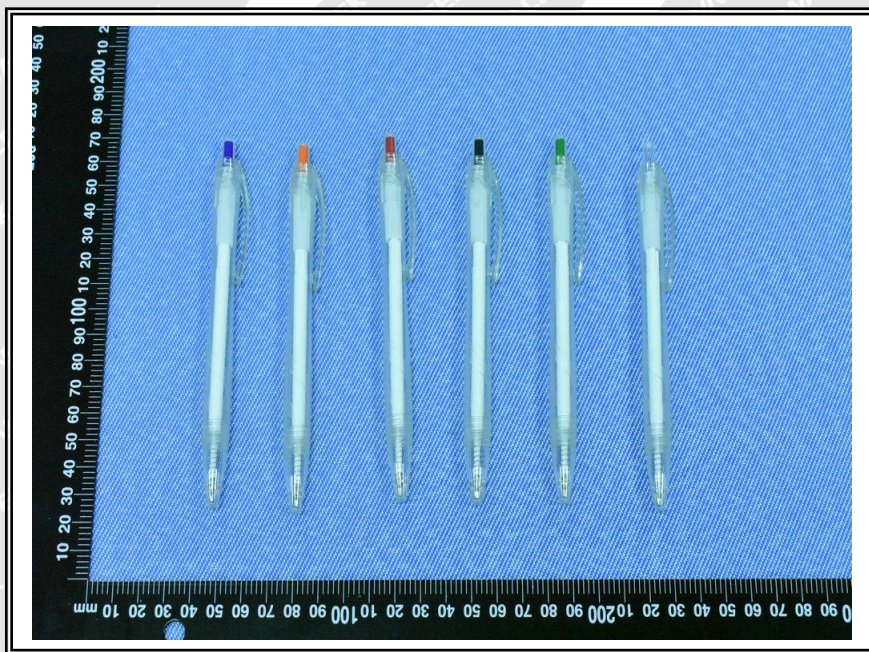

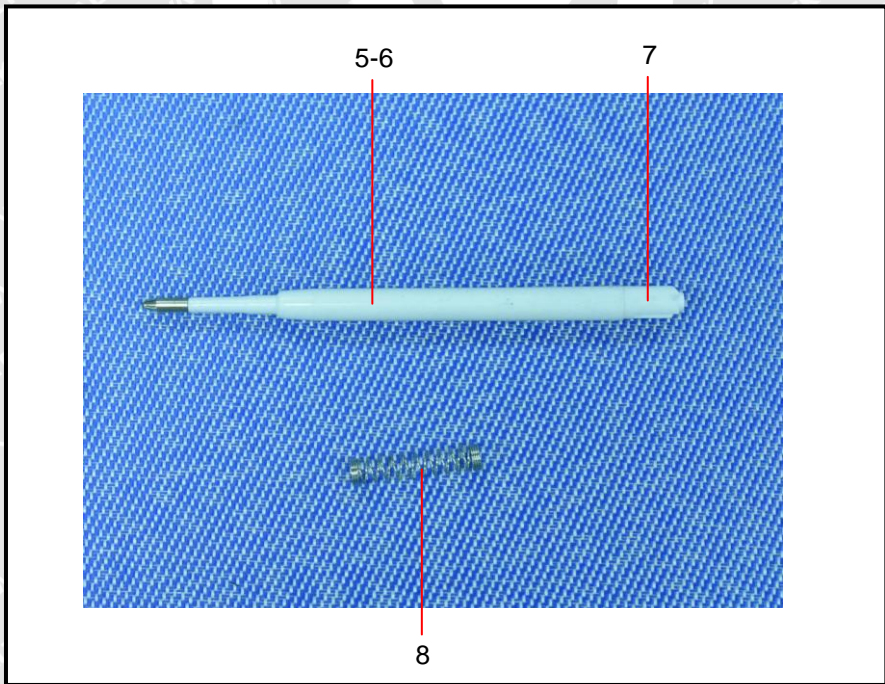
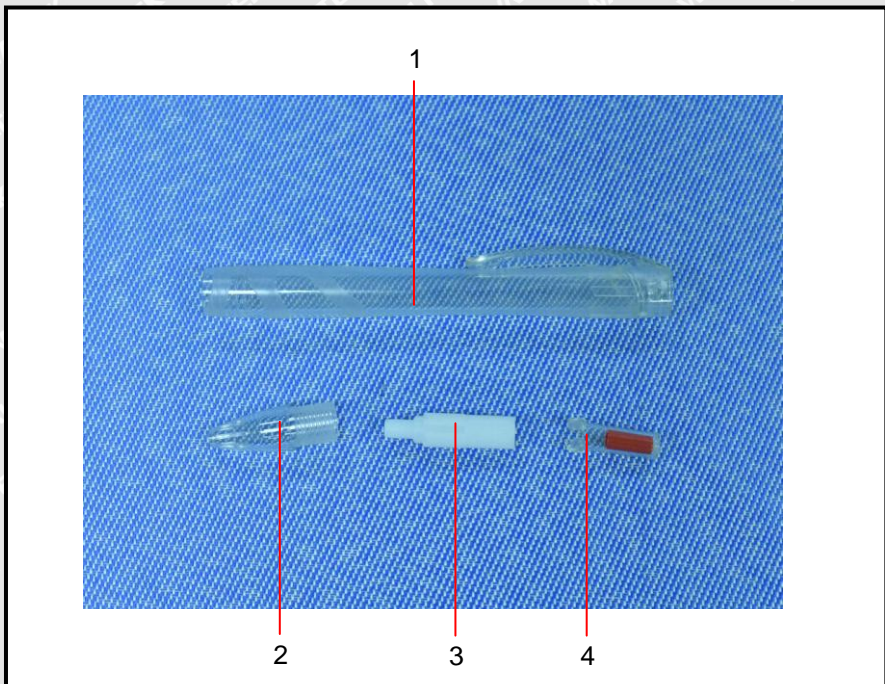
- No.1: Transparent plastic barrel
