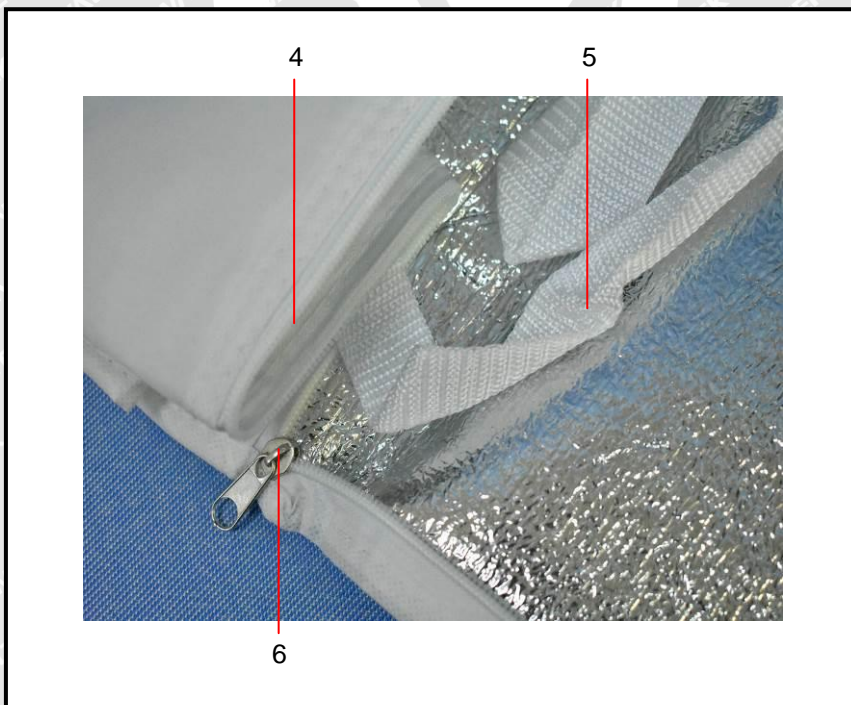
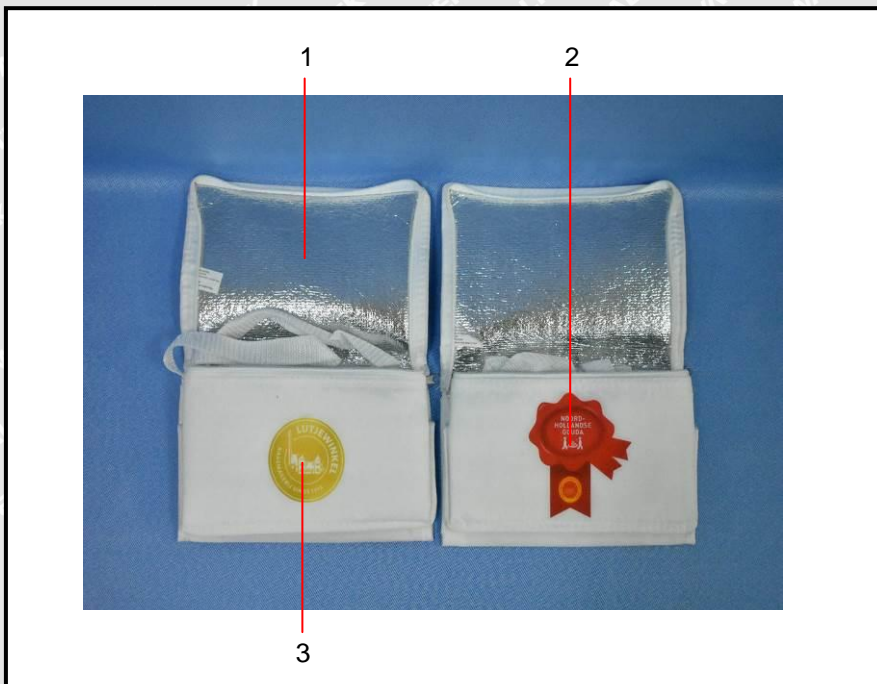
- No.1: Silvery thermal insulation material
