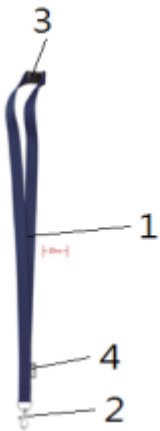
Sustainability Declaration
