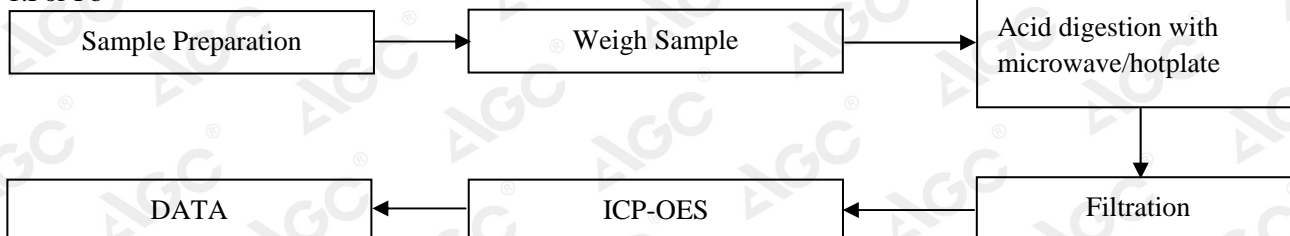

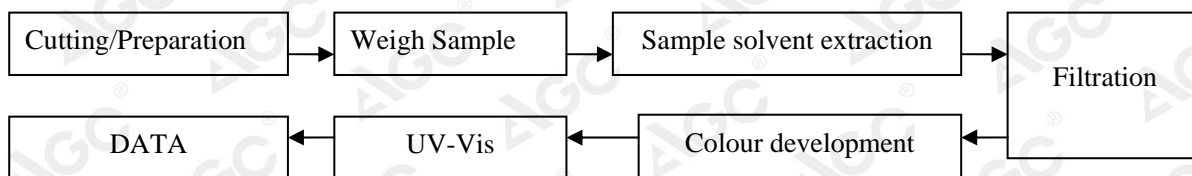

1. For Pb

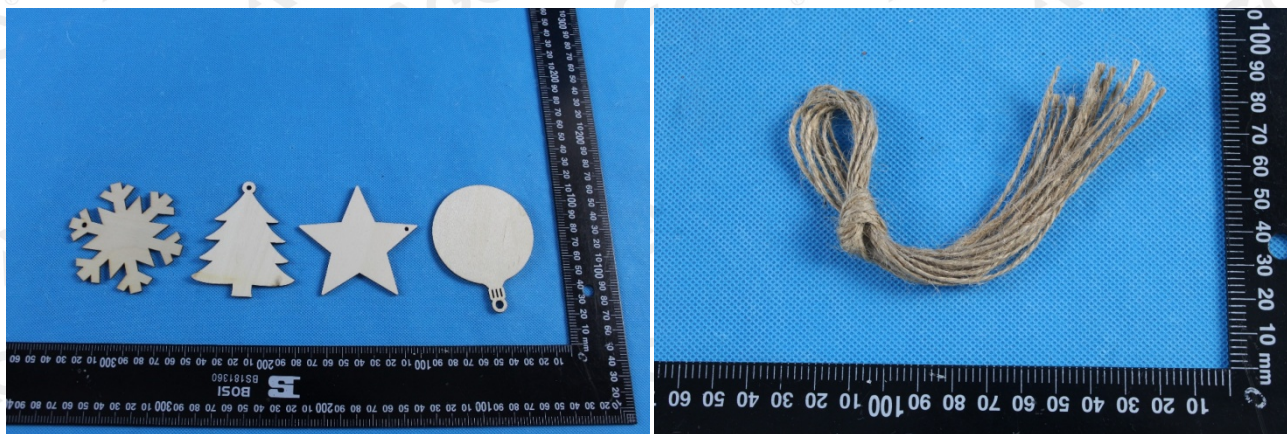


2. For formaldehyde
